## Re: A.25-03-010 et al, Cost of Capital Proceeding

Dear Governor Newsom & California Public Utilities Commissioners,

California residents are struggling with an unprecedented utility affordability crisis. New requests from California's investor-owned utilities (IOUs) to increase their authorized profits will worsen this crisis. The undersigned organizations strongly urge you to reject the unwarranted increases in rate of return, including return on equity (ROE), that the IOUs have requested in the Cost of Capital proceeding. In fact, we believe the ROE and the overall rate of return should be reduced.

Since the utilities submitted their applications in March, significant evidence has emerged that challenges the utilities' requested ROE rates. Stakeholder testimony demonstrated that the IOUs requested returns—ranging from 11% to 11.75%—are unjustifiably higher than market conditions warrant. Leading financial firms estimate long-term U.S. equity market returns at an average of 6.06% for the general market, which is considered riskier than utility investments. As shown in the table below, California IOUs' ROE is already above the national average, and their proposed increase would collectively extract an additional \$917 million from California ratepayers with no corresponding improvement in service.

## The IOUs are currently requesting significant ROE increases:

PG&E	10.28% to 11.30% (+1.02%)	\$351.6 million
SCE	10.33% to 11.75% (+1.42%)	\$351.7 million
SDG&E	10.23% to 11.25% (+1.02%)	\$96.45 million
SoCalGas	10.08% to 11.00% (+0.92%)	\$117.4 million

## We respectfully urge you to:

- 1. Reject these unwarranted ROE increase requests.
- 2. Reduce the rate of return for California's utilities.
- 3. Prioritize affordability in the CPUC's decision-making process when considering any future rate and ensure that there is no increase in profits through other means, such as paring back requests to expand capital investments.

Other states are taking decisive action to scrutinize utility profits. The Connecticut Public Utilities Regulatory Authority has denied gas company rate increases and required millions in customer refunds.<sup>2</sup> The Illinois Commerce Commission cut utilities' proposed rate increases and return on equity, saving customers hundreds of millions of dollars.<sup>3</sup> The California Public Utilities Commission should join this movement by more thoroughly scrutinizing the utilities' proposals and prioritizing ratepayer interests.

Reducing the current excessive ROE would provide immediate relief to struggling ratepayers while still allowing utilities to attract necessary capital investment. Your leadership on this issue would send a powerful message that California's investor-owned utilities are not entitled to demand excessive profits at the expense of California's families and businesses that are already struggling to make ends meet during this affordability crisis.
